

## **WOKTOBER CONTEST (the “Contest”)**

### **CONTEST RULES AND REGULATIONS**

#### **MTY FRANCHISING INC. (“Manchu Wok”)**

### **1. Contest Period**

The Contest begins at 12:00:01 a.m. Eastern Time on October 1, 2025 and ends at 11:59:59 p.m. Eastern Time on October 31, 2025 (the “**Contest Period**”).

### **2. Eligibility**

To enter and be eligible, a participant must be a resident of Canada who has reached the legal age of majority in their province of residence. Despite the foregoing, employees, officers, shareholders, directors, representatives, mandataries, and agents (including their immediate family members and members of the same household) of Manchu Wok and those of its affiliated companies, subsidiaries, vendors, suppliers, distributors, service providers, advertising and promotion agencies (collectively, the “**Related Parties**”) are not eligible to enter or participate in the Contest.

By participating in the Contest, each participant agrees to be bound by these Contest Rules and Regulations. Participants further agree to abide by and be bound by all decisions of Manchu Wok in respect of the Contest. All such decisions shall be final and binding upon those choosing to participate in the Contest.

### **3. How to Enter**

No purchase is necessary to enter or win. A purchase does not increase odds of winning.

Entries will be collected through the Wyng platform. Limit of one (1) Entry per person during the Contest Period. Any attempt to exceed this limit by using multiple names, identities, email addresses, or any other method will void all such Entries.

Once submitted, an Entry cannot be deleted, cancelled, or modified. Incomplete or fraudulent entries, or entries submitted in violation of these Contest Rules and Regulations will be automatically rejected.

#### **4. Prize**

There is one (1) prize available to be won, consisting of a **\$500 Manchu Wok Gift Card** (the “**Prize**”).

The Prize must be accepted as awarded, without substitution, transfer, or exchange, and has no cash surrender value. Manchu Wok reserves the right, in its sole discretion, to substitute a prize of equal or greater value if the Prize cannot be awarded as described.

On or about **November 5, 2025**, one (1) Entry will be randomly selected from all eligible Entries received during the Contest Period. The random selection will be conducted using Wyng's random draw process.

The selected entrant will be notified by email within five (5) business days following the draw date. To be confirmed a winner, the selected entrant must:

1. Respond to the notification email within seven (7) business days; and
2. Correctly answer, without assistance, a time-limited mathematical skill-testing question.

Failure to meet these requirements will result in disqualification, and another entrant may be randomly selected.
